Requirements of DTFA

For the statewide program, agencies must meet the following criteria in order for the Dave Thomas Foundation for Adoption to award funds:

1. **Qualified 501c3 organization – tax exempt status.**
2. **Primary focus is adoption out of foster care (they must provide foster care adoption in some way, shape or form, otherwise we would have to write the check out of Stanton Charities for Children).**
3. **Some record of activity must exist – they can't be new as of the event.**
4. **They must provide an IRS statement showing they are a 501c3, brochure/annual report and an audited financial statement.**
